(c) Establishment of preschool and early child hood education center.

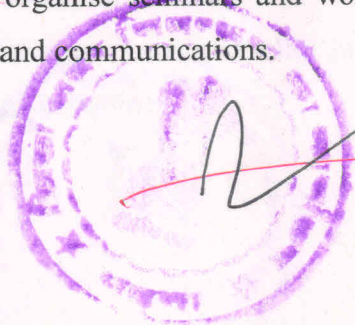

**10. POWER & FUNCTION OF THE TRUSTEES:**

(a) The TRUSTEES shall be at liberty, at their absolute discretion to accept any property, contribution, grants, collection or donations from persons, firms, companies or government or other institution, including foreign agencies/institution or foreign governments, for the advancements of the objects of the Trust.

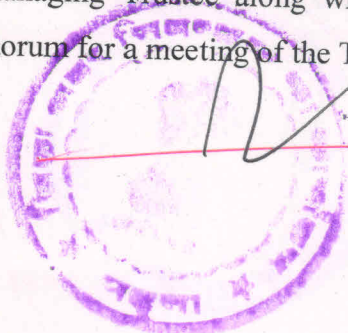

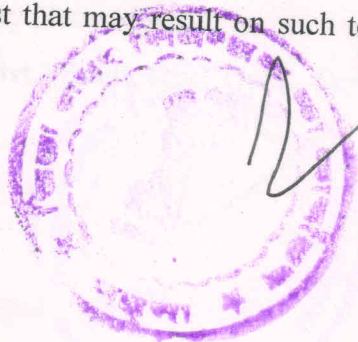
(e) The Trustees shall keep or cause to be kept a minute book of the proceedings of the meetings.

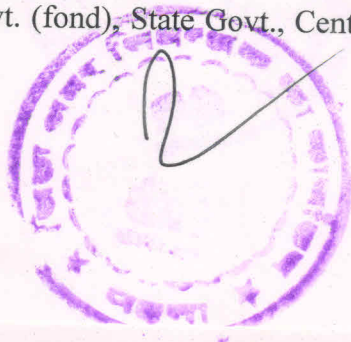
